

Thoughts from our Supreme Chaplain, Rev. Andrew S. Hvozdovic ALL SOUL'S DAY CUSTOMS AND TRADITIONS

All Souls' Day, in Roman Catholicism, a day for commemoration of all the faithful departed, those baptized Christians who are believed to be



in purgatory because they died with the guilt of lesser sins on their souls. It is observed on November 2. Roman Catholic doctrine holds that the prayers of the faithful on earth will help cleanse these souls in order to fit them for the vision of God in heaven, and the day is dedicated to prayer and remembrance. Masses for

the dead are commonly held, and many people visit and sometimes decorate the graves of loved ones. It is part of the three-day triduum dedicated to remembering the dead, beginning with Halloween (October 31) and followed by All Saints' Day (November 1) and All Souls' Day (November 2).

From antiquity certain days were devoted to intercession for particular groups of the dead. The institution of a day for a general intercession on November 2 is due to Odilo, abbot of Cluny (died 1048). The date, which became practically universal before the end of the 13th century, was chosen to follow All Saints' Day. Having celebrated the feast of all the members of the church who are believed to be in heaven, the church on earth turns, on the next day, to commemorate those souls believed to be suffering in purgatory.

Catholics celebrate All Souls' Day in a variety of ways, including:

• Prayer: Catholics pray for the souls of the faithful departed, especially those who may not be saints.

• Mass: Catholics attend Mass on All Souls' Day, though it is not a Holy Day of Obligation.

• Cemetery visits: Catholics visit the graves of their loved ones, pray, and leave flowers or other decorations.

• Lighting candles: Catholics light candles for their loved ones as a space for prayer and remembrance.

- Alms: Catholics give alms.
- Good works: Catholics do good works.

• Soul cakes: Catholics make soul cakes, which are small, round cakes with sweet spices, to commemorate the dead.

WHY THANKSGIVING FOOD BECAME SO POPULAR

Thanksgiving foods like turkey, cranberry sauce, stuffing, mashed potatoes, and pumpkin pie are more than just delicious, they've become essential parts of the holiday due to their historical roots, seasonal availability, and cultural significance.

Turkey, the star of the meal, became a Thanksgiving staple because it was plentiful and large enough to

arge enough to feed many people. Early American settlers found it practical for big gatherings,

and by the mid-19th century, turkey was closely tied to the holiday, especially after President Lincoln's 1863 Thanksgiving proclamation.

Cranberries, native to North America, were harvested by Native Americans long before the Pilgrims arrived. Their natu-

ral ripening in the fall made them a fitting addition to the holiday table.



Early settlers cooked them into sauces for preservation, and with the rise of commercial canning in the 1900s, cranberry sauce became an easy and popular Thanksgiving side dish.



Stuffing, with its ancient roots, was brought to America by European settlers who stuffed poultry with

bread and herbs to enhance flavor.

Over time, families personalized stuffing recipes, making it a versatile dish that reflects regional and cultural traditions, which has kept it a beloved Thanksgiving favorite.

Mashed potatoes, another comforting and easy to make dish,

became popular as potatoes grew into a staple crop in the 18th century. Paired with



gravy made from turkey drippings, this combination became the ultimate Thanksgiving comfort food.

Pumpkin pie completes the meal as a symbol of the fall harvest. Pumpkins, also native to America, were used by early settlers to cre-



ate pies, and by the 19th century, pumpkin pie was a traditional dessert. Its association with the autumn

season and the harvest made it the quintessential Thanksgiving sweet treat.

These foods became popular not just for their flavors, but because they represent the harvest, history, and abundance of early America. Together, they have become synonymous with Thanksgiving, bringing people together each year in celebration of gratitude and tradition.

A Thank You to all Veterans for your service to our country! God Bless you all!





SS. CYRIL AND METHODIUS APPEAL OF THE SLOVAK CATHOLIC FEDERA-

TIPS FOR COOKING THE PERFECT THANKSGIVING TURKEY

Thawing a frozen turkey requires patience. The safest method is to thaw turkey in the refrigerator. Be sure to plan ahead — it takes approximately 4-5 days for a 20-pound turkey to fully defrost.

For crisper skin, unwrap the turkey the day before roasting and leave it uncovered in the refrigerator overnight.

When calculating your roasting time, plan on about 15 minutes per pound.

Cook the turkey on a rack of vegetables. Create a natural roasting rack for your turkey by layering carrots, onions and celery on the bottom of the roasting pan. Lifting the turkey off the base of the pan helps to increase hot air circulation around the whole bird so that it will get crispy all over. And the vegetables add great flavor to the gravy.

Brining is an easy way to a moist and flavorful turkey. A typical brining solution contains water, salt, sugar and a variety of spices and aromatics. Just be sure to follow a trusted recipe so you get the right proportion of each.

Keep the stuffing on the side. Cooking the stuffing in the turkey can provide ground for the growth of harmful bacteria. In addition, a stuffed turkey will take longer to cook, which could result in drier white meat. Instead, loosely fill the turkey with aromatics such as onions and herbs, and cook the stuffing separately.

Before putting the turkey in the oven, make sure the skin of the turkey is as dry as possible, and then rub it all over with butter or oil. For even moister meat, place pats of butter under the skin.

Skip the basting. Basting means more oven door opening, resulting in temperature fluctuations that can dry out your bird. Instead, keep your turkey moist by brining it or by rubbing it all over with butter or oil.

Check for doneness by inserting an instant-read thermometer in the thickest part of the turkey around the thigh, avoiding the bone. At 165 degrees F, it's done. The turkey will continue to cook as it rests, so the temperature should rise another 10 degrees or so out of the oven.

To lock in juices, tent your turkey with foil and let it rest for at least 15 to 20 minutes before carving. Be sure you don't cover the turkey too tightly as you don't want the bird to steam under the foil.

THANKSGIVING RECIPES

TURKEY IN A CUP

In a small bowl, beat 1/2 cup spinach dip and 4 oz softened cream cheese with electric mixer on high speed about

1 minute or until well mixed. Cut turkey head from yellow bell pepper. Cut 1/2-inch triangle from red bell pepper for turkey wattle. Cut 1/2x1-inch strips from desired colors of bell peppers for feathers. Spoon 2 tablespoons dip into each of 5 (2- to 3-oz) cups. Place



turkey head in cup; attach peas for eyes using spinach dip. Insert pepper triangle for turkey wattle. Place colored pepper strips behind head for feathers.

GREEN BEAN CASSEROLE

Cook 2 pounds green beans in boiling salted water until crisp-tender, 5 minutes; drain. Saute the green beans with 1



pound sliced button mushrooms in 2 tablespoons butter in a large ovenproof skillet over medium heat, 5 minutes. Add 1 teaspoon each minced garlic and kosher salt, and 1/4 teaspoon allspice; cook 2 minutes. Add 1/4 cup instant flour.

Whisk in 1 cup each chicken broth and half-and-half; bring to a boil. Top with canned fried onions. Bake at 400 degrees F until bubbly, 15 to 20 minutes.

PERFECT CRANBERRY SAUCE

Empty a 12-ounce bag of fresh or frozen cranberries into a saucepan and transfer 1/2 cup to a small bowl. Add 1 cup

sugar, 1 strip orange or lemon zest and 2 tablespoons water to the pan and cook over low heat, stirring occasionally, until the sugar dissolves and the cranberries are soft, about 10 minutes. Increase the heat to medium and cook until the cranberries burst, about 12 minutes. Reduce the heat to low and stir in the reserved



cranberries. Add sugar, salt and pepper to taste and cool to room temperature before serving.

BASIC STUFFING

Preheat the oven to 375 degrees F. Melt 1 stick butter in a large skillet over medium heat. Add 2 cups each diced onions



and celery, 2 chopped apples and 1 tablespoon each minced sage and thyme; season with salt and pepper and cook 5 minutes. Add 3 cups chicken broth and bring to a simmer. Whisk 2 eggs with 1/4 cup chopped parsley in a large bowl;

add 16 cups cubed stale country white bread, then pour in the vegetable-broth mixture and toss. Transfer to a buttered 3-quart baking dish and dot with more butter. Cover and bake 30 minutes, then uncover and bake until golden, 20 more minutes.

4 p.m. in St. Christine's church hall at 3165 S Schenley Ave, Youngstown, OH 44511.


We worked very hard to keep the price the same as last year at only \$25 per person (\$10 4-11years, free for 3 & un-

What's making headlines in our ancestral homeland



PELLEGRINI: UN BACKBONE OF WORLD ORDER DESPITE SHORTCOMINGS

New York, September 25 (TASR-correspondent) - The UN, despite its shortcomings, is the backbone of a world order based on rules and international law, Slovak President Peter Pellegrini said during the 79th UN General Assembly in New York on Wednesday.

Pellegrini noted in this vein, that "there are countries and entities among us that believe that the absence of rules will be the breeding ground for their future success" and that "they believe that force is above the law", adding that such an attitude will one day come back to haunt them.

The president noted that there has been a war in Ukraine, Slovakia's neighbour, for almost one thousand days. Pellegrini called the war "the result of Russia's aggression, which violated such basic principles of international law as sovereignty and territorial integrity". Pellegrini noted that Ukraine is legitimately defending itself against this aggression. He expressed concern at the escalation of the conflict and called for a "peaceful, sustainable and just end" to the conflict on the basis of international law.

At the same time, the president touched upon the war in the Gaza Strip and the collapse of the state in Haiti and Sudan.

Pellegrini went on to criticise the lack of political will among members of the UN Security Council to resolve armed conflicts. According to him, this is a consequence of the fact that Council members can keep each other in check. Addressing the discussion of a possible in-depth reform of the UN, Pellegrini declared that Slovakia is ready to help with this "legitimate effort". At the same time, he highlighted the role of regional associations, such as the EU and NATO. He spoke against the division into the global North and South and instead recommended looking at which countries follow rules and which countries don't.

Pellegrini also touched on the spread of misinformation. "It is of utter importance that we speak out against those who abuse words by giving them alternate or even opposite meanings," he said. On this note, he also mentioned climate change and criticised its denial.

According to the president, the role of the UN and its institutions is protecting freedom, human rights and dignity, but also fighting against poverty and improving public health, including maintaining vaccination standards.

Another topic that the president touched upon was migration. "We must not forget that most of our ancestors across Europe were refugees too - when they fled before war, poverty or persecution during Nazism or Communism," he declared, calling for the introduction of clear rules and measures to help source, transit and destination countries of migration. It is also legitimate, he said, to point out security risks of migration, in particular irregular migration, but this must be done in a calm manner.

MILITARY AIRCRAFT PICKED UP SLOVAKS IN LEBANON

A military aircraft left for Lebanon on Friday (October 4) to pick up Slovaks in Lebanon.

It also took to Lebanon a humanitarian shipment of food and medical supplies of more than two tons. In addition, Slovakia is cooperating with other countries that have expressed interest in helping their citizens to return.

"Our embassy is constantly in contact with the citizens of the Slovak Republic in Lebanon, who receive all the necessary information to decide whether they are interested in the evacuation. Currently, 31 Slovak citizens are registered, including employees of the embassy and their family members," said head of Slovak diplomacy Juraj Blanar, adding that the Slovak embassy in Beirut continues to operate in the necessary crisis mode.

Slovakia is also cooperating with other countries in the evacuation to assist the citizens of these countries in leaving Lebanon. More than 40 citizens of Armenia, the Czech Republic, France, Croatia, Hungary, Poland, the United States of America, and Serbia have so far requested the use of Slovak evacuation flights. They are to be transported to Larnaca, Cyprus, by the Slovak military aircraft.

BRATISLAVA TRANSPORT MUSEUM OPENS EXHIBITION TO MARK 110 YEARS OF VIENNA TRAMWAY

The Slovak Technical Museum (STM) - the Transport Museum in Bratislava on Thursday opened an exhibition to mark 110 years since the launch of the Vienna Tramway.

The exhibition was organised on the occasion of the 25t^h anniversary of this specialised museum, which documents the history of transport in Slovakia, presenting and expertly managing collected exhibits of road, rail and water transport.

The current exhibition will take visitors back to 1914, when Bratislava and Vienna were connected by a local electric railway. The new transport connection between two important cities of the-then monarchy enjoyed great interest among the population and was also a technical attraction. "In the first year of its operation alone, 3 million passengers were transported on the route from Vienna to Presporok [the Slovak name for Bratislava at the time]. In the-then Presporok this line was known among people as the 'Vienna Tramway'," said the exhibition's curator Michal Jajcaj. He emphasised that it was an electric railway, which was not a common thing in those days, as steam engines were used by most rail services.

The exhibition will feature the interesting history of the Vienna Tramway via information panels and exhibits in the

The exhibition will be open to the public between October 11 and September 30, 2025.

FOUR OFFICIALS DISMISSED OVER ASSASSINATION ATTEMPT ON PREMIER

Two directors of the Office for the Protection of Constitutional Officials and Diplomatic Missions have been dismissed over the assassination attempt on Premier Robert Fico (Smer-SD), Interior Minister Matus Sutaj Estok (Voice-SD) stated on Tuesday, adding that he also dismissed the regional deputy of the police in Trencin and the district director of the Police Corps in Handlova (Trencin region) in the summer.

On the assassination attempt, Sutaj Estok received a report from the director of the Office for the Protection of Constitutional Officials. "The factual background was stated there. The main critical factor that emerged from that report was that in 2023 training for the members of the Office for the Protection of Constitutional Officials was neglected. They didn't go through the training that they should have gone through, and on that basis, personal accountability was also drawn," he stated, adding that security clearances were also neglected in 2023 and in the years before. According to the minister, the officers who were dismissed were not members of the Police Corps who were present at the shooting of the premier, but officials.

As for the report on the circumstances surrounding the May 15 assassination attempt against Prime Minister Robert Fico (Smer-SD), Sutaj Estok noted that it's being drafted by the Slovak Intelligence Service (SIS), he's not familiar with its details and has no access to the investigation file. "The report is to be submitted to Parliament by the end of the year at the very latest," claimed the minister, who hopes that at least a part of it will be declassified for the public.

The prime minister was shot following an away-fromhome cabinet meeting in Handlova on May 15 by Juraj C. [name abbreviated due to legal reasons], who is now being prosecuted for a particularly serious crime of terrorist attack. The attacker caused several serious injuries by shooting at the premier five times from a close range.

SLOVAKIA GETS EC APPROVAL FOR DISBURSE-MENT OF FOURTH RECOVERY PLAN PAYMENT

Slovakia received approval for the full payment of the fourth instalment from the recovery plan, head of the National Implementation and Coordination Authority's communication department Olga Dubravska has told TASR, adding that the European Commission confirmed that the penal amendment doesn't contradict the milestones of the recovery plan.

"We've met all fifteen milestones in the fourth payment request, which guarantees us a payment of €799 million. After assessing the additional information, the EC concluded that the original milestone concerning the fight against corruption and the independence of the judiciary is not considered to have been reversed and therefore the application is positively evaluated," said Vice-Premier for the Recovery Plan Peter Kmec (Voice-SD).

The value of the entire application was €923 million. After deducting the part of the pre-financing Slovakia has already received, a payment of €799 million is expected in the next few days. This funding will make it possible to implement a number of reforms, such as improving the integration and financing of long-term social and health care, and reforming guidance and prevention in the area of mental health support for children, pupils and students.

"This example shows that the negotiations with the European Commission are conducted at a very professional and correct level and I'll be glad if we don]t make the recovery plan in Slovakia a political competition. Let's focus on the result and be proud of what we've achieved today," stated Kmec.

Slovakia has submitted four applications so far. The recovery plan foresees a total of nine payments until its end in 2026. Slovakia will submit the fifth payment application in December this year.



The region of Nitra is made up of a low plain. It adjoins Hungary to the south with the Danube forming a border between the two countries. In 1248, Nitra became an independent royal town. It suffered from several of the Turkish invasions in the seventeenth century. Nitra castle, which houses the cathedral complex and extensive museum and treasury, is one of the area's most popular tourist attractions. A number of art galleries offer various exhibitions and the Andrej Bagar Theatre offers the best in drama, comedy and the musical arts.

DANIEL F. TANZONE

Our former editor Daniel F. Tanzone passed on Friday, October 18.

A native of Yonkers, N.Y., Daniel F. Tanzone was born there April 1, 1947 son of the late Daniel J. Tanzone and the former Mary R. Yancus. His paternal



grandparents were natives of the village of San Feli in the Calabria region of southern Italy, while his maternal grandparents, John and Elizabeth Yurco Yancus were born in the village of Fricovce in eastern Slovakia. His Slovak grandparents emigrated to the United States in June 1895 and settled in Yonkers, where they were among the founders of the former Most Holy Trinity Slovak Parish there and were the tenth marriage solemnized in the

new parish on July 6, 1895.

Dan was graduated from the former Most Holy Trinity School where his teachers were the Sisters of SS. Cyril and Methodius. He is a 1965 graduate of Sacred Heart High School in Yonkers. He received his Bachelor of Arts degree with a major in English at Holy Apostles Seminary College in Cromwell, Conn. in 1971. He pursued graduate studies at Fairfield University, and St. Mary of the Lake Seminary in Mundelein, III.

He has been active in the Slovak Catholic Sokol since 1964. He was elected as a Member of the Physical Fitness Board of Group 1 in 1968. He began serving as an officer of Assembly 219 in Yonkers while in his early twenties. He served as president of Assembly 219. He was elected a Supreme Auditor of the Slovak Catholic Sokol in 1975. He began serving as the assistant to Editor John C. Sciranka, his longtime mentor and inspiration, in March 1979. Following the death of Brother Sciranka in October 1980, he assumed the position of editor of the Slovak Catholic Falcon. He has served in this capacity for the past 37 years. As a representative of the Sokol, he has served as president of both the New York and the New England Fraternal Alliance. The 32nd quadrennial convention elected him an Honorary Supreme Officer.

He has also been active in the work of the Slovak League of America, a civic and cultural organization of Americans of Slovak ancestry. In 1976, he served on the Editorial Board of the Slovak League which published the book, "Slovaks in America, A Bicentennial Study." That same year, he penned the book, "Slovaks of Yonkers, New York."He was first elected as national president in 1985 and served until 1993. He was again elected president in 2006, a position he currently holds. He also served as a member of the Executive Board of the Slovak Catholic Federation, an organization which promotes and coordinates activities among Slovak Catholic fraternal societies and parishes in the United States. He is a past president of the organization's Eastern Region.

He was active at the former Most Holy Trinity Parish in Yonkers, NY until its closing in 2015. There, he was a former parish trustee and president of the parish council.He also served on the finance committee of the United Parish of St. John Nepomucene, St. John Martyr and St. Frances Xavier Cabrini in Manhattan. He was a memberof the First Catholic Slovak Union, the First Catholic Slovak Ladies Association, the National Slovak Society and the Ladies Pennsylvania Slovak Catholic Union.

Over the years, he has been the recipient of numerous awards and recognitions. In 1980, he was honored for his work by the New Jersey Slovak Heritage Festival. In 1995, he received the Presidential Gold Medal of Slovakia's first president, Michal Kovac during his U.S. visit. In 1996, Pope St. John Paul II, at the recommendation of the Slovak Catholic Federation awarded Dan the "Pro Ecclesia et Pontifice Medal" - For the Church and the Pontiff, for his activities in various Church related causes. In 1999, the Sisters of SS. Cyril and Methodius of Danvile, PA presented him with the Saints Cyril and Methodius Award for Evangelization and Inculturation of Peoples. That same year, he was honored as Man of the Year of the Pulaski Police Association of Westchester County. In 2005, he was solemnly invested as a Knight of the Equestrian Order of the Holy Sepulchre of Jerusalem at St. Patrick's Cathedral in New York by the Archbishop of New York, Edward Cardinal Egan.

Brother Dan was also the recipient of the 2017 Slovak Catholic Sokol Fraternalist of the Year.

Civically, Dan has served on a number of city and county boards. In 1974, he was named a member of the Yonkers Youth Advisory Council. In 1975, he was named to the Westchester County Board. On two occasions, he served on the Mayor's Blue Ribbon Panel in Yonkers, a screening panel for candidates being considered for membership on the city's Board of Education. For eight years, 1986-1994, he served on the Yonkers Civil Service Commission.

As a journalist, Dan has contributed numerous articles over the years to a variety of publications. He serves on the editorial board of "Slovakia" a scholarly journal published by the Slovak League. He has been an officer of the Slovak Newspapermen's Association of America for many years.

Dan retired as Editor of the Slovak Catholic Sokol in December 2017.

NA SLOVENSKO PRICHÁDZA NOVÁ INVESTÍCIA

TEKVICOVÉ KOLÁČE SLANÝ KOLÁČ S TEKVICOU A SO SLANINKOU

Cesto: 200 g múka hladká, 100 g maslo, 3 PL voda, štipka soľ

Pĺnka: 500 g (maslová alebo hokkaido) tekvica, 120 g (prerastená) slanina, 1 ks cibuľa červená, 2 ks vajcia, 150 g strúhaný (ementál) syr, 100 ml smotana na varenie, 250 ml smotana kyslá, olej, korenie čierne mleté, oriešok muškátový, soľ, vňať petržlenová na ozdobu.

V mise zmiešame múku, studené maslo, soľ a vodu. Vypracujeme cesto, ktoré zabalíme do potravinárskej fólie a odložíme na 30 minút do chladničky. Tekvicu ošúpeme, zbavíme semienok a nakrájame na kocky. Ošúpanú cibuľu nakrájame nadrobno. Na troške oleja orestujeme cibuľu dosklovita, pridáme tekvicu a ďalej opekáme niekoľko minút. K tekvici a cibuli pridáme nakrájanú slaninu a ešte krátko opekáme. V mise zmiešame kyslú smotanu, smotanu na varenie, vajcia a nastrúhaný syr. Zmes ochutíme soľou, korením a strúhaným muškátovým orieškom. Nalejeme k tekvici a všetko spolu premiešame. Vychladené cesto rozvaľkáme medzi dvoma hárkami papiera na pečenie do tvaru kruhu. Vrchný papier odstránime a aj so spodným papierom vložíme do koláčovej formy s priemerom 26 až 28 cm. Cesto prstami roztlačíme aj do bokov. Na cesto vo forme navrstvíme plnku a slaný koláč pečieme približne 45 minút v rúre vyhriatej na 200 °C. Môžeme podávať ozdobený petržlenovou vňaťou za tepla aj za studena.

Tento krehký slaný koláč môžete pripraviť aj so šunkou, s údeným mäsom alebo aj celkom bez mäsa. Na ochutenie plnky sa hodia aj rôzne bylinky, napríklad tymian a oregano. Okrem ementálu môžete nastrúhať do plnky aj eidam, goudu alebo syr s modrou plesňou. Namiesto klasickej pšeničnej múky sa na cesto bude hodiť aj špaldová hladká múka alebo zmes hladkej a celozrnnej múky.

TEKVICOVÝ KOLÁČ SO SYROM

*Cesto:*315 g múka polohrubá, 1 KL soľ, 225 g maslo, 120 ml ľadová, voda

Plnka: 400 g tekvica, 4 ks veľké vajce, 120 ml smotana, 120 ml mlieko plnotučné, 250 g syr tvrdý, 2 strúčiky cesnak, korenie čierne mleté, soľ, tymian, olej olivový

Múku, soľ a na kocky nakrájané vychladené maslo vymiešame do hladka. Pridávame vodu po lyžiciach a miesime dokým sa vstrebe. Na doske vypracujeme cesto, dokým sa maslo zapracuje. Cesto zabalíme a dáme chladiť na 2 hodiny. Rúru vyhrejeme na 200 °C. Tekvicu očistíme, nakrájame, dáme na plech, polejeme olejom, ochutíme soľou, korením a tymianom. Na plech dáme 2 strúčiky cesnaku a pečieme 20-30 minút, alebo dokým nezmäkne. Necháme vychladnúť. Teplotu v rúre znížime na 190 °C a koláčovú formu vytrieme maslom. Cesto vyvaľkáme na tenko (1 cm) a vtlačíme do formy. Cesto vystelieme papierom na pečenie a nasypeme záťaž (ja používam hrach). Dáme piecť na 15 minút. Vyberieme papier a záťaž, spodok cesta popicháme vidličkou a dáme piecť na 8 minút. Teplotu v rúre znížime na 170 °C. Upečenú tekvicu, cesnak a mlieko rozmixujeme dohladka. V mise zmiešame tekvicovú zmes. smotanu, vaicia a vyšľaháme. Nakoniec pridáme nastrúhaný syr, tymian, sol' a korenie. Vylejeme na predpečené cesto a pečieme 45 minút.

Šalvia lekárska má protizápalové, antivirotické a antibakteriálne účinky. Čaj zo šalviových listov sa pije proti kašľu a pri poruchách trávenia či dokonca na zmiernenie potenia.

Jablčný ocot má antibakteriálne vlastnosti. Vďaka svojej kyslosti môže pomôcť rozpúšťať a uvoľňovať hlieny v hrdle a zastaviť šírenie baktérií. Ak máte pocit, že sa v hrdle začína rozmáhať zápal, vyskúšajte kloktať vodu s dvomi lyžičkami jablčného octu. Medzi-tým pite dostatok vody.

Tymián sa osvedčil ako prostriedok proti nadúvaniu a zápalom tráviaceho traktu. Mierni kašeľ a vo všobecnosti má protizápalové účinky. Vďaka svojim účinkom sa dá využiť pri liečbe nachladenia, kašľa, bolesti v krku a infekciách v ústach. Dá sa použiť pri inhalácii, ako ústna voda, alebo kloktadlo.

Repík má mimoriadne široké uplatnenie. Pomáha pri problémoch s tráviacou sústavou, má močopudné účinky, pri žlčníkových a močových kameňoch, pri poruchách pečene. V jesennom a zimnom období môže pomôcť pri liečbe nádchy a kašľa. Keďže má sťahujúci účinok, používa sa aj na rany.

Mäta dokáže omnoho viac, než len osviežiť dych. Výluh zmierňuje bolesť hrdla a tíši kašeľ. Vďaka obsahu mentolu uvoľňuje hlieny. Mäta má protizápalové vlastnosti a preto môže okrem liečenia vírusových a bakteriálnych infekcií pomôcť aj pri hojení rán.
