Message from our Supreme President Michael J. Horvath

The Board of Directors held their 3rd Quarter meeting September 28 -29, 2018 at the Airport Marriott in Cleveland, Ohio, the site of the Slovak Catholic Sokol 33rd Convention. The normal agenda of busi-



normal agenda of business was conducted; review of the financial position of the Organization, hear from our investment and financial advisor, PNC Bank, go over the sales and marketing report, briefed on the semi-annual audit review, updated on legal and mortgages is-

sues, hear from the Physical Fitness Board and discuss unfinished business and new business.

The Board of Directors had meaningful discussion on all of the agenda items and reports with no issues or major concerns. The only item that we all have to try and correct is the decline in membership. This is something that has to be watched over the next several months since we are losing more members from deaths and surrenders, something that we cannot control, than from new issues. Even with the decline in membership the sales goals on premium income and face values are on target for 2018.

On Saturday, September 29, 2018 the 2020 Committee held its meeting at the Airport Marriott to continue the work it is doing on the governance and Board structure of the Society. In the first session the Committee reviewed the work it has compiled over the last six (6) months. Each Committee member went over the Slovak Catholic Sokol office they were assigned to review and give their analysis on how it compares with the same office of the other fratemals.

In the second session the 2020 Committee met with each Board of Director individually to obtain from them what they thought of the position, its importance, duties known and unknown, what hampers the office and what will improve the function of the office. After all the Board of Directors were interviewed a joint session was held with the members of the 2020 Committee and the Board of Directors to go over the finding to make sure all was correct and to see if any changes needed to be made. The 2020 Committee's final report will be presented at the 4th Quarterly Board of Directors meeting in December 2018.

On September 5-6, 2018, Supreme Secretary, Scott T. Pogorelec, F.I.C. and I attended the American Fraternal Alliance (AFA) Annual Meeting in Minneapolis, MN. This was the AFA's last Annual meeting since it is changing its operations and meeting style. They will now have a presence in Washington, D.C. which will be more in tuned with legislative issues that affect the existence of fraternal societies. At a session on Board diversity, I heard presenters say Boards should be diverse and made up with many different members. This I agree with, a Board should represent a Society's membership, from gender, geographical footprint, to Board qualifications and experiences. The one important issue that also presented itself is one diversification plan does not fit all societies. Each Society is different and needs a plan of diversity that works for them.

The other message that came from the meeting is, Fraternals where created to do activities to help its members and communities. This is how fraternal societies are measured and is what separates us from the commercial insurance companies. Slovak Catholic Sokol Assemblies, Wreaths and Groups need to tell their stories to the Home Office on what activities they are doing so they can publish them in the Falcon and documented. These activities then can be reported in the annual reports to the various state insurance departments which then will show the number of activities, members involved, the hours volunteered, and charitable organizations served in our communities. Help us show how great the Slovak Catholic Sokol is and uncover our shining fraternal light.

With the upcoming Halloween events and parties being sponsored by Assembly, Wreaths and Groups, I ask all to send in pictures of our ghoulish members and an article about the scary night.

As you have read in the Falcon we have a new membership initiative, the WIN-WIN Lead Campaign. I hope all members will get involved in this Campaign which will help the Society reverse its declining membership problem. Thoughts from our Supreme Chaplain, Rev. Andrew S. Hvozdovic OCTOBER, RESPECT LIFE MONTH

The Catholic Church has consistently taught that every human life is precious and worthy of protection. Every intentional abortion is gravely wrong. In April 2018 Pope

Francis wrote: "Our defense of the innocent unborn-needs to be clear, firm and passionate, for at stake is the dignity of a human life, which is always sacred and demands love for each person, regardless of his or her stage of development."



The Church does not approach difficult pregnancy decisions with a false "either/or" mentality, pitting mother against child. For example, a baby conceived

in rape is not an aggressor deserving death by abortion. She is innocent, like her mother. They both deserve compassionate care and support, not more violence. Abortion doesn't bring healing or peace, but both can be found in the courageous decision to give birth to the baby.

Today, many babies diagnosed are so severe that the baby is likely to die before or soon after birth, "many parents who carried their children to term say that protecting their baby and honoring his or her natural life, no matter how brief, was profoundly healing."

Very rarely, continuing a pregnancy may put a mother's life at risk-for example, because of a tubal pregnancy or aggressive uterine cancer. It is morally licit to remove the threat to the mother's life by removing the cancerous uterus or the fallopian tube where the child implanted, even though it is foreseeable that the child will die as an indirect and unintended result of such surgery. But abortion-a direct and intentional taking of a child's life-is never morally permissible.

Pray daily for the end of abortion, that all mothers and children experience the loving support of the Church community, and that all who suffer after abortion find healing and peace.

Be a Part of the Fraternal Season Ahead

My Mom: Martha Parry By Richard Parry

On July 28, 2018, my mom, Martha Sipka Parry turned 100 years old. She was the former president of St. Mary's Branch 2 of the F.C.S.L.A. and a longtime Sokol member of Assembly 219 in Yonkers, NY. Other members of the branch are grandsons Clifford and Matthew Ainsworth, niece Sue Gagner, and me, her son Richard Parry.

The 100th birthday celebration was well attended by friends and family from all over the US as well as maternal and paternal family members from Bratislava and Veselé Slovakia.

Mom's mother, Suzanna Nemec, came to America in 1912 from Šaštín, Slovakia. Mom was delivered at home by a midwife in Newark, NJ. She was a first generation born American, the oldest of three children.

Suzanna was unable to support three children, so my mother entered a foster home at the age of 5. It was not uncommon for my mother to be treated badly including corporal punishment which was a prevalent practice in foster homes at the time.

Mom was raised in a Slovak neighborhood in Newark, NJ and spoke only Slovak. It wasn't until she was in a foster home that she was exposed to English.

My mother married in 1941. Dad joined the Navy during WWII and mom worked in a factory riveting military planes, she was "Rosie the Riveter".

My sisters and I lived in the Bronx and attended Catholic schools. We all made it through school and have mom to thank.

Mom worked for NYC in various administrative positions. She would routinely take civil service exams to advance in her career.

It was not until my sisters and I left



home that my mother was able to pursue her dream of a college degree. For 5 years she worked during the day and attended school at night. At the age of 60 she received a BS degree from SUNY.

In 1984 mom retired. She travelled several times to Slovakia to bond the family and keep the family relationship alive. She also entered several Senior Olympic events and has medals to prove it.

Mom lost her husband in 1991, her daughter Lonnie in 2002 and her other daughter Joanne in 2013.

In 2013 mom moved to San Diego where we both live today. She has lived through the Great Depression, the loss of a mother, a father, a husband, two sisters, two daughters, and yet she overcame these tragedies. She is a friend to all that meet her. She smiles and laughs and few would believe the many bumps in the road she travelled; I'm proud to call her my mom.

SKS 2020 Committee Meeting August 15/23 and September 19, 2018 – Conference Call(s)

The SKS2020 Committee met on several occasions via conference call in preparation for presenting our draft proposals to the Board of Directors at their September meeting. The next agenda item was review and approval of the SKS 2020 Committee Meeting Minutes from June 7, 2018. Suhlas.

In preparation for this meeting, Sister Dobbs shared the committee member recommendations for each proposed Board of Director role. The expectation for the multiple meetings was to gain consensus regarding:

- Job pre-requisites/requirements
- Job description
- Voting or non-voting
- Elected or hired
- Term limits

The committee members each led discussion regarding their assigned role proposal. There was specific intent to strengthen job requirements in order to add a layer of governance protection. General discussion regarding job descriptions resulted in a proposal to ask the Board of Directors to review their own role job description for recommendation to our committee at the September Quarter 3 BOD meeting. Post review and discussion regarding each role, a vote of the committee members was taken. In each case, there was 100% agreement. A summary of the discussion will be shared with the Board of Directors for their feedback as was part of the new motion recommendation and expectation of our committee.

Supreme Secretary Scott Pogorelec reminded this group that we will be meeting in person in conjunction with the September BOD meeting (September 28-30) in order to pull together our final thoughts regarding recommendation. At this meeting, the SKS2020 committee will have opportunity to individually interview current board members seeking their input. Our timeline continues to be on track for a final proposal to the BOD at their annual meeting in December of 2018.

Supreme President Michael Horvath asked this committee to consider opportunity to strengthen our board through diversity. The committee was asked to bring thoughts to the Board of Directors meeting for further discussion.

Brother Michael also suggested that he would be interested in discussion regarding the development of a standing "governance" committee whose responsibility would be to assess, review and advise the board at some defined interval between conventions. More to come on this topic.

Sister Dobbs thanked everyone for their participation and preparation. Brother Michael offered a closing prayer as conclusion to the three meeting process.

SLOVAK PARLIAMENT COMMEMORATES 170TH ANNIVERSARY OF PREDECESSOR

The Slovak national anthem was played in Parliament (officially National Council of the Slovak Republic) on Wednesday to commemorate the 170th anniversary of the Slovak National Council, which was a political body set up during the 1848 Revolution and could be regarded as a predecessor of both the current Slovak Parliament and Government.

"The Slovak National Council existed for only a short time, but it represented with dignity the Slovak nation in its fight for self-determination, a self-reliant status, the codification of the state language, for spiritual and material renewal and in its efforts to achieve statehood," said Parliamentary Chairman Andrej Danko (Slovak National Party/SNS).

"The struggle for modern Slovak statehood began 170 years ago. The emancipation efforts of the Slovak nation culminated on January 1, 1993 with the setting up of an independent and democratic Slovak Republic," added Danko.

The Slovak National Council held its first session at an inn called 'U Sperla' in Vienna on September 15-16, 1848. Headed by leading Slovak national revivalists Ludovit Stur, Michal Miloslav Hodza and Jozef Miloslav Hurban, it became the first national political body of Slovaks and the headquarters of the armed Slovak uprising in 1848-49. When the revolution was suppressed, the Slovak National Council ceased to exist in the autumn of 1849.

The Slovak National Council is commemorated in Slovakia by a Day of Remembrance on September 19, the date when in 1848 the council organized the first national meeting of Slovaks in Myjava (Trencin region) to launch a Slovak volunteer campaign for the uprising, while Stur declared Slovakia's independence from the Kingdom of Hungary.

SLOVAK AMBASSADOR TO USA IVAN KORCOK RECEIVES TRANSATLANTIC AWARD

Ostrava, September 17 (TASR) – Slovak Ambassador to the USA Ivan Korcok received the Czech and Slovak Transatlantic Award on the sidelines of the NATO Days in Ostrava on Sunday (September 16), NGO GLOBSEC has announced on its website.

Ian Brzezinski, son of US foreign policy legend Zbigniew Brzezinski, handed over the award to the Slovak ambassador. Korcok was honored for his many years of efforts to support transatlantic relations.

In 2002, Korcok led the Slovak delegation during accession talks with NATO, whose member Slovakia became in 2004. Korcok's significant engagement in European politics over the past ten years, during which he served as ambassador to Germany and to the EU, was also noted at the award ceremony.

"The relationship between the EU and the USA is undergoing its toughest test in its history. The last thing we need is to send messages over the Atlantic Ocean via the media. We need to communicate the more that we have different opinions on several issues. However, this doesn't mean that we'll draw apart from each other. The USA and the EU can't afford to become rivals on the global chessboard," stated Korcok, who assumed the post of Slovak ambassador in Washington just a few days ago.

"For 26 years of Slovak diplomacy, Mr. Korcok excellently served his country, earning merit in terms of respect and appreciation from politicians on both sides of the Atlantic Ocean. He contributed considerably to the development of the EU

GAJDOS: SLOVAKIA HAS PLENTY TO OFFER ALLIES REGARDING BOMB DISPOSAL

Even 14 years since Slovakia became the leading country in the area of explosive ordnance disposal (EOD) within the whole of NATO, the country still has something to offer its allies and partners in this regard, stated Defence Minister Peter Gajdos (SNS) in his speech to open the two-day NATO EOD Demonstrations and Trials 2018 exhibition, which is taking place in Bratislava between September 19-20.

"Proof that we have an irreplaceable role in this area is our engagement in Ukraine, where we're the leading country of the NATO Trust Fund for explosive ordnance disposal and dealing with improvised explosive devices," said the minister. He further pinpointed the EOD Demonstrations and Trials exhibition, which is organised by the Trencin-based NATO Explosive Ordnance Disposal Centre of Excellence (NATO EOD COE) every two years.

Gajdos pointed out that more than 360 exhibitors from 22 countries are participating in the exhibition this year. "This record number also confirms the importance, relevance and added value of this activity," he said, stressing the main theme of this year's exhibition – a Multidisciplinary Approach to EOD.

The fifth NATO EOD Demonstrations and Trials exhibition is aimed at presenting the latest trends and technologies in the fields of explosive ordnance disposal and improvised explosive devise disposal to experts of NATO-member and -partner countries as well as to the academic community and representatives of industry.

IFP: SLOVAKIA'S GDP TO GROW BY 4.1% THIS YEAR; UP TO 4.5% IN 2019

Slovakia's GDP growth will reach 4.1 percent this year and accelerate to 4.5 percent in 2019 thanks to automotive sector exports, before slowing down to 3.9 percent in 2020, according to the latest macroeconomic prognosis published by the Finance Ministry's Financial Policy Institute (IFP) and presented by Finance Minister Peter Kazimir (Smer-SD) on Thursday.

Household consumption, which was

the main driving force in the past, will be replaced by revived exports as well as investments. Growth in exports has been accelerating thanks to the automotive industry, with the launch of new production at Volkswagen (VW) already reflected. "Rapid growth in investments was largely driven by Jaguar Land Rover's (JLR) investment as well as an acceleration in public investments, chiefly by local governments," stated IFP. Demand for labour should bring 47,000 new jobs and rapid growth in salaries, but also increased inflation.

In 2019, household consumption will maintain a growth pace similar to previous years thanks to increases in salaries. However, higher salaries will chiefly be reflected in price growth. "Exports will dominate again, speeding up thanks to the launch of production by JLR and thanks to the ongoing production expansion at VW," stated IFP. Conversely, growth in investments will slow down due to the completion of new capacities at automotive plants.

In 2020, the Finance Ministry expects GDP growth to slow down to below 4 percent due to the fading effect of automotive production launches. "In this period we can still expect an increase in production at JLR thanks to the launch of a second model. However, export growth will be hampered by a cyclic deceleration in the economies of our main trading partners," said IFP.

CZECH POLICE: SLOVAK ISLAMIST WAS PLANNING LONE WOLF ATTACK

The first Slovak Islamist radical identified for legal purposes only as Dominik K., arrested last year in the Czech Republic, was actually planning a terror attack, Czech police chief Tomas Tuhy told Czech Television on Sunday, September 23.

The radicalized Slovak, who frequented mosques in Prague and appeared under the adopted name of Abdul Rahman, wasn't a member of an organised group and should rather be considered a 'lone wolf', said Tuhy.

"This person really was planning a terror attack. Only excellent cooperation between the intelligence services and the Czech police prevented a possibly serious incident from taking place," said Tuhy.

The young man originating from Slovakia stated that his spiritual role model was a former Prague imam who was ear-

lier charged with supporting terrorism but managed to flee. He's wanted for supporting his brother and a sister-in-law who have joined jihadists in Syria.

The Muslim community in the Czech Republic didn't alert the authorities about the radicalization of the Slovak. According to the police chief, it seems that Dominik K. wasn't part of an organised group, however.

The Slovak living in the Czech Republic converted to Islam three years ago. It was found that he posted disturbing messages on a social network, including one with the slogan: "This country will be ours! And it won't be for everyone!"

After converting to Islam, he began wearing military garb and greeting others with a raised right forefinger, a salute used by the Islamic State terror group.

The man, who was found by the police to have suspicious chemicals and manuals for producing a bomb at his flat, claimed that he only intended to use the substances to make New Year's Eve fireworks, but the police found his explanation unconvincing.

"The chemicals were meant for producing weapons, not petards. As a Muslim, he shouldn't celebrate New Year's Eve," noted the Czech police's anti-terrorist department.

DANKO OPENS EXHIBITION OF PHOTOS ON DUBCEK IN GREEK PARLIAMENT

Visitors to the Greek Parliament in Athens will have the opportunity to see an exhibition of photographs dedicated to the memory of Slovak politician Alexander Dubcek (the leading figure in the Prague Spring of 1968), jointly opened by Slovak Parliamentary Chairman Andrej Danko (Slovak National Party/SNS) and his Greek counterpart Nikos Voutsis on Monday, September 24.

"As the top representative of the Greek Parliament, I'd like to express my thanks and admiration for the work done by this prominent politician. The year 1968 was significant not only for Czechoslovakia itself; the events of that year influenced developments in other countries as well," stated Voutsis after viewing the exhibition. At the same time, he presented a medal of the Greek Parliament to the Slovak parliamentary chairman.

The opening of the exhibition formed part of Danko's official visit to Greece. Be-

fore meeting Voutsis, the Slovak parliamentary chairman visited Greek President Prokopios Pavlopulos.

Danko also met with Kyriakos Mitsotakis, leader of the Greek Opposition and of the New Democracy party. On Tuesday (September 25), Danko was received by the Archbishop of Athens and all Greece. This is the first visit paid by a Slovak parliamentary chairman to Greece since 2005.





Stara Lubovna is situated on the Poprad River east of the High Tatras. It is one of the oldest towns in Spis. From a hill over the city the castle of Lubovna dominates the city. From its already reconstructed tower there are good views over the surroundings. Next to the castle there is an open-air museum, Lubovniansky skanzen, with many houses and other buildings showing the folk architecture of the region. The most interesting exhibit is the wooden Greek-Catholic church built in 1833.

Tasty Fall Recipes

CUBRY PUMPKIN SOUP

2 tablespoons pumpkin seeds (optional)

2 tablespoons butter

3 tablespoons all-purpose flour

- 2 tablespoons curry powder
- 4 cups vegetable broth

1 (29 ounce) can pumpkin 1 1/2 cups half-and-half cream 2 tablespoons soy sauce 365 Everyday Value® Organic Soy Ginger Sauce

Preheat oven to 375 degrees F. Arrange pumpkin seeds in a single layer on a baking sheet. Toast in preheated oven for about 10 minutes, or until seeds begin to brown.

Melt butter in a large pot over medium heat. Stir in flour and curry powder until smooth. Cook, stirring, until mixture begins to bubble. Gradually whisk in broth, and cook until thickened. Stir in pumpkin and half-and-half. Season with soy sauce, sugar, salt, and pepper.

Bring just to a boil, then remove from heat. Garnish with roasted pumpkin seeds.

PUMPKIN BREAD

1 (15 ounce) can pumpkin puree 4 eggs 1 cup vegetable oil 2/3 cup water 3 cups white sugar 3 1/2 cups all-purpose flour 2 teaspoons baking soda 1 1/2 teaspoons salt 1 teaspoon ground cinnamon 1 teaspoon ground nutmeg 1/2 teaspoon ground cloves 1/4 teaspoon ground ginger Add all ingredients to list

Preheat oven to 350 degrees F. Grease and flour three 7x3 inch loaf pans.

In a large bowl, mix together pumpkin puree, eggs, oil, water and sugar until well blended. In a separate bowl, whisk together the flour, baking soda, salt, cinnamon, nutmeg, cloves and ginger. Stir the dry ingredients into the pumpkin mixture until just blended. Pour into the prepared pans.

Bake for about 50 minutes in the preheated oven. Loaves are done when toothpick inserted in center comes out clean.

ROASTED PUMPKIN SEEDS

1 1/2 cups raw whole pumpkin seeds 2 teaspoons butter, melted 1 pinch salt

Preheat oven to 300 degrees F. Toss seeds in a bowl with the melted butter and salt. Spread the seeds in a single layer on a baking sheet and bake for about 45 minutes or until golden brown; stir occasionally.





Going out to a pumpkin patch to pick pumpkins, is a fun filled rite of the Fall season. Whether you go out to a field filled with pumpkins, or get them from a roadside stand, we want to be certain that you get the absolutely best pumpkin for carving, decorating and eating!

Select pumpkins that are completely orange. A partially green pumpkin might not ripen any further.

Size is an important factor. Medium pumpkins are best for carving into a Jack O Lantern. Small pumpkins are better for cooking and baking.

Never lift or carry a pumpkin by it's stem. The stem gives it character.

A ripe pumpkin has a hard shell, that does not dent or scratch easily when pressing on it with a thumbnail. Do this on the back or bottom of the fruit......never on the face.

Examine the entire pumpkin carefully for soft spots. If you find even one soft spot, go on to the next pumpkin.

Check the pumpkin for cracks and splits. If you find one, examine it to be sure it is not turning into a soft spot or has mold inside of the crack.

Look for bugs and insects. Specifically, look for holes in the pumpkin, which are indicative of insect problems.

Cut the vine on either side of the stem. After you get it home, you can trim off the remaining pieces of vine, and cut the stem at the perfect spot.

Select a healthy pumpkin. When you're choosing a pumpkin, try to pick one that's free of nicks, bruises, and cuts. Look for a sturdy stem that doesn't feel too bendable, and for mostly consistent color all the way around. Knock or thump on the skin like you would a melon; if you hear a hollow sound, the pumpkin is ripe.

Look for a pumpkin with a flat base. This will make it easier to display the carved pumpkin on Halloween night.

It's not important if the pumpkin you like is clean or dirty. Remember you can always wash the pumpkin with an old cloth when you get home.

Trump prijal v pondelok 19. septembra v Bielom dome vo Washingtone, D.C. nového slovenského veľvyslanca v USA Ivana Korčoka, ktorý americkému prezidentovi odovzdal poverovacie listiny a stal sa tak siedmym mimoriadnym a splnomocneným veľvyslancom Slovenskej republiky v Spojených štátoch. Ivan Korčok pred odchodom do USA pôsobil vo funkcii štátneho tajomníka rezortu diplomacie a vo funkcii veľvyslanca v USA vystriedal Petra Kmeca, ktorý v tejto funkcii pôsobil od roku 2012. Ceny leteniek z Viden do New Yorku na historickom minime

Pobyt v New Yorku už pre Slovákov nie je luxusom, vďaka dlhodobo priaznivým cenám leteniek si ho môže dovoliť čoraz viac ľudí. Slováci sa naučili rýchlo reagovať na aktuálne ponuky a letenky do New Yorku kupujú impulzívnejšie – často len na predĺžený víkend.

Ceny spiatočných leteniek do New Yorku sa dva roky výrazne nemenili. Dlhodobá priemerná cena bola približne päťsto eur. New York je najobľúbenejšia diaľková destinácia Slovákov, pričom sa predáva rovnako dobre počas celého roka. Výkyvy v predaji nastanú vtedy, keď cena výrazne klesne.

Slováci najviac rezervujú letenky do New Yorku, ak cena klesne pod psychologickú cenovú hranicu. Takými hranicami môžu byť ceny pod štyristo alebo tristo eur. Letenky do New Yorku ešte nikdy nestáli tak málo – vyplýva to zo štatistík Pelikan.sk, ktorý ročne pomôže s nákupom leteniek viac ako tristotisíc cestujúcim. Minulý mesiac začal Pelikán predávať letenky z Viedne do New Yorku za dvestotridsať eur. Podľa predajcu ide o historicky najnižšiu cenu z blízkeho letiska a s krátkymi prestupmi. Cena letenky do New Yorku sa prvýkrát vyrovnala cene letenky do Európy. Predaje Pelikána do New Yorku rástli deväťnásobne.

Kým v roku 2016 takmer osemdesiat percent Slovákov letelo do New Yorku na viac ako desať dní, dnes im stačí aj víkend. Keď letenka do New Yorku stojí dvesto eur, Slováci sa veľmi často rozhodujú impulzívne na základe ceny a neplánujú komplikované niekoľkotýždňové cesty.

Prezident Kiska na pracovnej ceste v USA

Prezident Slovenskej republiky Andrej Kiska sa zúčastnil na zasadnutí 73. Valného zhromaždenia Organizácie spojených národov v New Yorku, kde mal 26. septembra prejav, po ktorom absolvoval stretnutie s generálnym sekretárom OSN Antoniom Guterresom. Sretol sa aj s gruzínskym prezidentom Giorgim Margvelašvilim a ukrajinským prezidentom Petrom Porošenkom.

Prezident rokoval aj s predstaviteľmi spoločnosti AT&T, ktorá na Slovensku zamestnáva 4300 ľudí. Súčasťou programu prezidenta bola aj konferencia spojená s galavečerom Forbes 100 + 100 Years of Innovation, ktorá mala za cieľ spájať slovenských, českých podnikateľov a amerických investorov. Prezident sa na galavečeri stretol aj so Stevom Forbesom.

26. septembra prezident Kiska odletel do Chicaga, Ill. Položením venca k pamätníku Tomáša Garrigua Masaryka v Chicagu si spolu so slovenským veľvyslancom v USA Ivanom Korčokom uctili jedného zo zakladateľov Československa. Urobili tak pri príležitosti stého výročia jeho vzniku.

Prezident okrem Masarykovho pamätníka navštívil aj Chicagskú univerzitu, kde študentom priblížil svoju cestu na prezidentský post, aj to, že kedysi v USA pracoval. Navštívil aj Benediktínsku univerzitu, kde sa stretol so Slovákmi žijúcimi v USA, a Slovak Academy of Chicago, kde sa desiatky detí každú sobotu učia slovenčinu.

Miroslav Lajčák zavŕšil ročné pôsobenie v OSN



Celý rad konkrétnych výsledkov a úspechov dosiahlo Valné zhromaždenie Organizácie Spojených národov (VZ OSN) pod vedením ministra zahraničných vecí a európskych záležitostí SR Miroslava Lajčáka, ktorý ukončil v 1. októbra svoje ročné pôsobenie vo funkcii predsedu 72. zasadnutia tohto medzinárodného orgánu.

"Slovenská republika a slovenská diplomacia získali uznanie a posilnili si svoj kredit. Nová dynamika v práci OSN sa pretavila do schválenia troch kľúčových reformných iniciatív generálneho tajomníka OSN Antónia Guterresa (reštrukturalizácia piliera mieru a bezpečnosti, reforma rozvojového systému a reforma ria-denia organizácie)," uviedol vo svojej správe tlačový odbor Ministerstva zahraničných vecí a európskych záležitostí (MZVaEZ) SR.

Lajčák sa podľa neho angažoval ako "pozitívna hnacia sila týchto a ďalších zmien".

Rezort v tejto súvislosti poukázal na júlové schválenie návrhu prvej komplexnej medzivládnej dohody o bezpečnej, zákonnej a usporiadanej migrácii, ktorá má byť prijatá v decembri na medzivládnej konferencii v marockom Marrákeši.

Kľúčovou prioritou Lajčáka ako predsedu VZ OSN bolo "oživenie multilateralizmu a posilnenie globálneho poriadku založeného na pravidlách, aby OSN preukázala svoj význam a pridanú hodnotu". "Vo svojej práci aktívne podporoval dialóg a usiloval sa spájať členské štáty OSN s cieľom meniť životy ľudí k lepšiemu," uviedlo MZVaEZ s tým, že zameranie na ľudí úsilie o mier a dôstojný život pre všetkých na udržateľnej planéte - bolo oficiálnou témou celého 72. zasadnutia VZ OSN.

Lajčák sa prioritne orientoval na úzko prepojené a vzájomne sa ovplyvňujúce otázky zabezpečenia, budovania a udržania mieru a stability, na presadzovanie ľudských práv, financovania udržateľného ekonomického rozvoja, potláčanie hrozieb pre verejné zdravie, budovanie odolnosti voči zmene klímy a otázky vody a vodných zdrojov. V pozadí jeho iniciatív a úsilia bola vždy širšia vízia v oblasti prevencie konfliktov a podpory úlohy žien a mládeže v tomto kontexte.

Počas 12 mesiacov viedol Lajčák ako predseda VZ OSN viac ako 70 zasadnutí tohto orgánu a predniesol takmer 300 prejavov. Absolvoval viac než 440 stretnutí s predstaviteľmi členských štátov OSN (vrátane 26 prezidentov, 16 predsedov vlád, ôsmich podpredsedov vlád a viac ako 90 ministrov a štátnych tajomníkov) a viac ako 80 stretnutí s partnermi OSN, vrátane predstaviteľov iných medzinárodných a regionálnych organizácií a inštitúcií a občianskej spoločnosti. Zorganizoval desať podujatí VZ OSN na vysokej úrovni, poskytol viac ako 60 rozhovorov pre médiá a uskutočnil 20 pracovných ciesť do 36 miest v 28 krajinách.

Valné zhromaždenie OSN so sídlom v New Yorku je najvyšším a najreprezentatívnejším orgánom OSN, ktorý združuje všetkých 193 členských štátov OSN, a funkcia jeho predsedu je politicky a protokolárne najvyšším postom v systéme OSN. Slovenskej republike a slovenskej diplomacii sa tejto cti dostalo po prvýkrát, pripomenulo MZVaEZ.

Funkcia predsedu VZ OSN rotuje každý rok medzi piatimi regionálnymi skupinami členských štátov OSN. Ďalej je na rade región Latinskej Ameriky a Karibiku. Post predsedníčky 73. zasadnutia VZ OSN bude počas nasledujúcich 12 mesiacov vykonávať bývalá ministerka zahraničných vecí Ekvádoru María Fernanda Espinosová-Garcésová. – *sme.sk*
